EXPLANATORY STATEMENT PURSUANT TO THE PROVISIONS OF SECTION 102 OF THE COMPANIES ACT, 2013 IN RESPECT OF THE ITEM NO: 1 MENTIONED IN THE NOTICE OF ADJOURNED 68TH ANNUAL GENERAL MEETING.

Item No: 1

In the 68th Annual General Meeting held on 25th September, 2023 the matter for consideration of appointment of Committee of Administration (COA) members for the year 2023-2024 could not be concluded due to the fact that necessary directions were received from the Ministry of Commerce and Industry, Department of Commerce, Government of India to put on hold the elections process to fill any vacancies in the COA. This was done due to the fact that the Ministry was reviewing the existing guidelines and making suitable recommendations about representations of different stake holders in the Managing Committee and other post(s). In view of this directions the 68th Annual General Meeting was adjourned to 31st December, 2023 to consider the matter of appointment for COA Members for the year 2023-2024.

We have however, not received the consent from the said Ministry to proceed with the election process. Due to this no elections could take place to fill the vacancies in the COA especially those who will be retiring by rotation in the 68th Annual General Meeting. It has therefore been proposed by the COA at their meeting held on 22nd December, 2023 subject to the consent of the Members of the Council/Company to continue the present COA Members to hold office until the elections process takes place. The resolution for seeking the consent of the members is placed for approval.
