## NOTE

- 1) Regional Chairmen shall be directly elected by the **ordinary members of each respective region** and should have a minimum export turnover (FOB value of physical exports) in the immediate preceding financial year of a minimum of Rs 2 crores per annum, or average export turnover of Rs 2 crores per annum for the preceding three financial years.
- 2) There shall be one Regional Chairman in each region. The constitution of the three regions for which elections process is conducted is as under :
  - “Western Region” means the region covered by Maharashtra, Gujarat, Madhya Pradesh, Goa, Chhattisgarh and the Union Territory of Dadra, Nagar Haveli, Diu & Daman.
  - “Eastern Region” means the region covered by West Bengal, Odisha, Assam, Mizoram, Arunachal Pradesh, Sikkim, Andaman & Nicobar Islands, Bihar, Tripura, Manipur, Meghalaya, Jharkhand & Nagaland.
  - “Southern Region” means the region covered by Tamil Nadu, Karnataka, Kerala, Pondicherry, Andhra Pradesh, Telangana & Lakshadweep.
- 3) **Nomination indicating the name of the authorized representative of the Member eligible for election to any post of Regional Chairman, the same shall be proposed and seconded by the members of the same region.**
- 4) Only the authorized representative, whose name is mentioned as such in the membership application, while applying for membership with the Council shall be eligible to contest, propose or second at the Election.
- 5) However, in the absence / non-availability / unwillingness of such authorized representative, any person who is duly authorized by the existing partners / directors / managing committee member / trustee etc., as the case may be, shall be eligible to contest for the Election. Provided that the name of such authorized person as partner / director / managing committee member / trustee etc. is registered with Director General of Foreign Trade (DGFT).
- 6) Any Ordinary Member de-registered or black-listed under the Foreign Trade Policy with regard to exports / imports will not be eligible to file nominations for election to the Committee of Administration. Therefore, on the original Nomination Form itself the Member organization will also have to submit a declaration in writing signed by the Chairman / Managing Director / Director / Partner / Proprietor as the case may be that it is not debarred/black-listed under the aforesaid Policy.
- 7) In order to stand for the election to the post of Regional Chairman from a particular region, the address of the candidate registered with the Council for the purpose of membership must be with that region.
- 8) The candidate standing for elections should have a valid DIN (Director Identification Number) for standing for election.
