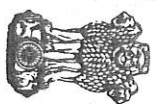

I congratulate the award winners and wish all the members of the exporting community a successful exporting year.

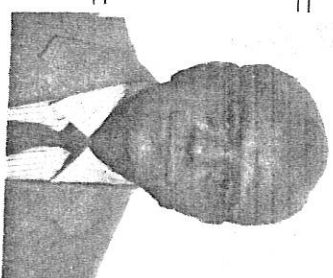

WELCOME ADDRESS BY
SHRI A. H. BHARUCHA, CHAIRMAN,
AT THE TOP EXPORTERS
AWARD FUNCTION HELD AT BOMBAY
ON THE 25TH NOVEMBER, 1993.

Hon'ble Minister Shri Pranab Mukherjee, Ladies & Gentlemen,
I am very happy to extend to you all a hearty welcome to the 17th Top Exporters Award Function of the Council.

I am also indebted to our Hon'ble Minister Shri Pranab Mukherjee for having responded to our Invitation and for being here amidst us today to felicitate our Top Exporters inspite of his heavy preoccupations.

I also wish to congratulate all Winners of Best Export Awards and Certificates of Merit for the past 2 years 1991-92 and 1992-93.

Our continuous growth in exports, and an extremely satisfactory progress during the past two years had been entirely due to the intensive efforts put in by the exporting members.

Shri Pranab Mukherjee has all along been a strong advocate of the current liberalised approach of the Government. We are indebted to him for his influence in framing of the Government's liberalised trade and fiscal policies. Past two years have witnessed far reaching changes in the trade and economic policies of the Government which have greatly improved the general conditions for exports.

The situation today has dramatically changed from the conditions prevailing in the previous years. By and large, the licensing system has been virtually abolished and almost all the items of raw materials, capital goods can now be freely imported with the exception of consumer goods.

The Customs duties have been slashed and the Government is committed to reduce them further in the coming years.

EPCG are also now permitted at concessional rate of Customs duty against corresponding export obligation.

Our export growth had been possible to a great extent on account of these progressive and bold economic reforms adopted by the Government. I would therefore once again like to express our sincere gratitude to Shri Mukherjee for creating such a conducive environment for promoting exports. These economic measures have certainly brought about the desired results in improving country's industrial production, progressive reduction of the inflation rate and lastly building up of Foreign Exchange reserves of more than 7 Billion US\$. Due to these policies we also witness a steady growth in the inflow of Foreign Investments and in maintaining fairly stable Rupee-dollar Exchange rate.

I would now like to review the present status of the Indian Plastic Industry as well as its export performance during the past few years.

Normally, the health of the Plastic Industry would be judged from the basis of per capita consumption of Plastics in the Country. Inspite of India having entered the Plastic Age over 4 decades ago, our growth remained way behind the advanced Countries. In developed economics, the per capita consumption is in excess of 60 Kgs. and the World average is around 14/15 Kgs. Today, even the economically backward Countries like Africa and Latin America, have per capita consumption around 3 Kgs and 8 Kgs. of Plastics respectively, as against this, the Indian per capita consumption stands meagerly at 1 Kg.

In a supply driven economy like ours consumption and usage is always dictated by the availability of basic inputs. In the 7th Plan, Petrochemicals has been identified as a core sector. On account of this a number of Petrochemical complexes have recently been completed and are on the anvil. This will improve the availability of Plastic Raw materials in the coming years. This is sure to bring about a quantum jump in the consumption of Plastic Raw Material both of local and imported sources in the coming years. At present Indian consumption of Plastics is estimated at 1.4 million tonnes. We already have a very wide base of processing units numbering over 15000 spread all over the Country. In terms of annual turnover, it would approximately be Rs.8,400 Crores (US.\$ 2.7 Billion). Even on a conservative estimate, the industry is expected to grow at a healthy rate of 15% per annum for the coming 5 years. As such by the year 2000 A.D. our per capita consumption should go upto 4 Kgs.

Until 1990, the Plastic Industry was singled out as Foreign Exchange Guzzler being a large importer of basic raw materials of app. Rs.1100 Crores in value per annum.

The responsible segments of the Industry did realise the need for development of export trade and on account of consistent focussing of this point by the Council on various platforms, our exports have steadily grown from Rs.128.93 Crores in 1988-89 to Rs.417 Crores in 1992-93. We have thus shown a consistent growth of approx. 15% during the past few years. What is really heartening is that this growth has been essentially in the General Currency Areas. During 1992-93, the percentage of growth in the above 20% and almost 95% of the total exports were to G.C.A. Our export figures only reflect the direct exports of finished Plastic products and do not cover a very large quantity of indirect exports by way of packaging materials electronic, telecommunication and automobile components which are estimated to be around Rs.600 Crores in the last year.

On certain select products, viz. Writing Instruments, Plastic Moulded and Extruded Goods, PVC Leather Cloth and PVC Sheeting, Plastic Floor Coverings, Thermoware etc. there has been 30% growth per annum in the last 3 years. We have therefore requested your Ministry to grant these Thrust products a status of 'Extreme Focus' hereafter.

For the year 1993-94, the Council has aimed to achieve US.\$ 156 million and during April-September 1993, our exports have already touched US.\$ 68 Million. We are confident to attain the target at year end.

Inspite of this healthy growth, when we compare ourselves with the international plastic trade, we realise how insignificant presence we have in global market. The total global exports of manufactured plastic products during 1992-93 were more than US Dollars 50 Billion.

Our very next door neighbour Mainland China, which appeared on the international trade scene very recently, exported to USA and European Countries alone to the tune of US.\$ 1.3 Billion during 1992-93. In terms of quantity China has exported over a million tonnes of semi-finished and single largest plastic products. This brings it very close to Germany, which is the tonnes in the last year. This comparison is not to belittle the efforts of our exporting community but to highlight the vast opportunities ahead of us in the coming years.

As I mentioned earlier the present day Government's Policies viz. full convertibility of Rupee on Trade account, recent devaluation etc. have brought about strong competitive edge to our products in the international market. Probably, these advantages may not last for a long period and the plastic industry will have to take maximum advantage by adopting aggressive marketing, technological upgradation, increased outlay towards R & D, and lastly by adopting total quality concept.

Sir, although our industry is today confident of achieving Rs. 1000 Crores exports by the year 1995-96, we will require active Government support to remove some of the major hurdles faced by the Industry.

I will take up these problems and hope they will receive your immediate attention.

(1) **Recent changes in the VABAL :**

Vide Notifications No.163(PN)/92-97 and No.15(RE)/92-97 dated 14th September, 1993 drastic Policy changes in the VABAL Scheme were announced with immediate effect.

The Industry and a majority of the exporting community do appreciate the need for change in the Policy on account of flagrant abuse of the Policy by a handful of irresponsible traders. However, the drastic step taken to transfer the major Polymers to Sensitive List of items, according to us was a 'panic reaction' rather than a corrective measure which should have also safeguarded the interest of genuine exporters. The industry would have been also very happy if simultaneous action were taken to bring to books such defaulters including the Government Officials concerned so as to ensure that such liberties are not taken in the future by the trade and industry. Instead, we find that genuine exporters are today hurt the most due to such radical changes in the Policy. Even in cases of exports completed, Foreign Exchange realised well before 14th September 1993, we are now informed by the Regional JDGFT's Office, that the issue of licence will be governed by the new provisions. Further on the licences already issued before 14th September, 1993 the LUT/Bank Guarantee of Grant of Waiver are not being entertained by the Licensing authorities in the absence of clear instructions from the Head Quarters. Sir, to Penalise the exporters at this stage is both, unethical and detrimental to their future interest in exports. I hope you will take immediate corrective action so that past exports are governed by the provisions of the provisions of the

Even now it would be worthwhile for the Government to examine the actual figures of raw material imports during January-June, 1993 to bring into focus the magnitude of polymerwise imports and its real adverse effect on the local raw material industry.

The revised Policy does not permit the 20% flexibility provision benefit in case the raw materials are obtained locally. I am unable to understand the logic of this step which will in effect compel the licence holder to import his requirements rather than obtain locally. On the other hand, local manufactures of raw materials are today looking out for export markets, which will be at an added loss of freight, handling expenses and the benefit of added value that would have accrued on processed product exports. We hope the benefit of 20% flexibility will be extended to the local suppliers also.

This flexibility percentage has also no bearing to the wastage factor of different product processes, high infrastructural costs on account of Power, freight, finance and the market development cost, the industry has to bear. Our study indicates that the flexibility percentage of 60% would effectively cover the above costs.

(2) **ECONOMICALLY VIABLE PRODUCTION BASE :**

In order to compete as well as to cater to the large volume requirements of the developed markets, it becomes imperative that we have production units of economically viable size of international standards. Unfortunately, a number of plastic products have been reserved for SSI Sector. This impediment should be removed forthwith so that new investments would flow in the areas where the existing export potential is very high.

The present EPCG scheme with 75% export guarantee requirement adds to the risk and cost burden for the entrepreneurs. This is mainly because already the established exporters from the Far East are well entrenched in these segments and it will take considerable long time before our exporting units will command the market confidence to achieve such high level of export commitments within the stipulated time of the Policy.

In the past, on this request of ours, the Government had responded favourably and we are still awaiting the necessary Policy changes.

PROVISION LIMITED TO

Policy, the industry is of the opinion that the period of export obligation should commence from the day of commissioning of the Plant as there is always a reasonable gap between import and commissioning of the Plant.

(4) REDUCTION OF CUSTOMS DUTY ON MOULDS & DIES :

Sir, we have been pleading for reduction of Customs duty on Moulds and Dies as well as for the inclusion of these items in the DEEC Licence with a value restriction of 10%.

International demands for changes in designs as well as specific market requirements demand frequent change of Moulds. Basically the Moulds and Dies should be considered as 'Consumables' although having a long life. When once the fashion goes out of market preference, which in case of moulded household goods remain a frequent necessity, should be permitted at the lowest possible import duty of 25%.

We hope the Government will concede to this request which we can assure will help to boost the exports of Moulded Goods.

(5) GRANT OF ADDITIONAL FUNDS :

Basically the Plastic Industry is dominated by SSI and medium sized manufacturing units. Although some of them are capable of entering export market on the basis of their product quality and competitive price are unable to venture into export field for lack of sufficient market information.

The Council has put forward a Programme to undertake such Market Research and International Publicity programme seeking financial assistance from the MDA funds to the tune of Rs.45 Lacs. Although in principle, the Hon'ble Minister of State for Commerce Shri Kamaluddin Ahmed and the Commerce Secretary, Shri Tejendra Khanna, favourably responded to make available such funds, till date, the release of funds has not yet taken place. You are aware that Government has progressively cut down the financial assistance to the Councils and in the absence of additional funds, the Council will not be in a position to undertake such surveys which are essential for export growth.

(6) CONTRIBUTION BY EXPORT HOUSE/TRADING HOUSE STAR

export performance mainly on account of the constructive and aggressive role played by their Trading Houses.

Our Trading Houses having their strong infrastructure and financial resources should undertake to harness the large scale unutilised capacities of SSI sector and help developing exports of their products.

Unfortunately most of our Trading House activities are confined to the exports of traditional items or selected high value added product exports only. We do accept that it will be our responsibility to educate the Trading Houses and highlight the export potential for the various Plastic processed products. We will however require your active support to persuade the major Trading Houses to back up our export efforts.

(7) REMOVAL OF OCTROI & SALES TAX :

Lastly, the Plastic Industry engaged in export activity like any other industry continues to suffer from the burden of high incidence of Octroi and Sales Tax on various inputs which in no way can be covered from our export pricing.

The Union Government will have to impose its decision on the State Governments and ensure that atleast export production is free of such cost burdens.

In addition to the selected issues referred to earlier, the industry also look forward to an attitudinal change in the minds of Officials at various levels who continue to mistrust, obstruct and harass the exporters, with the result that even the established exporters question the need for remaining in export trade. We find a tremendous gap between the Government's desire to give utmost importance to exports and the implementation of even the written Policy at every stage.

Before, I conclude, I would like to express my sincere thanks to you, Sir for participating in our Award Function. I will also take this opportunity to thank the various Officials of the Ministry of Commerce, DGFT and their Regional Offices, Collectors of Customs, and the Reserve Bank for their active cooperation to boost our exports.

I also take this opportunity to thank our friends from the Media for their presence and continued support.
