WELCOME ADDRESS

Respected Dr Ramaiah the Honourable Minister for Commerce and friends

It gives me great pleasure to welcome you all to this Export Award Function which indeed is a memorable event for all of us in the PLEXCONCIL when the top exporters from the plastic sector are honoured once in every two years.

I take this opportunity to accord a special welcome to the honourable Minister for spicing his valuable time out of his otherwise busy schedule and accepting our invitation of being amidst us today to honour the top export performers of our industry segment. Thank you very much, Sir, and your presence here will motivate all of us in bettering our export performance.

All Export Award Winners deserve a special welcome and in fact we are all here to honour them for their excellent performance. It is not out of place to mention that the aggregate export performance of all the export award winners accounts for about 50 percent of the total exports from the plastics sector. I take this opportunity to congratulate all the Award Winners who, I am sure, will act as a source of inspiration to other exporters to attain their level of exports.

The nation is celebrating the 50th year of independence and it is time we ponder over the thought as to whether we have achieved economic independence after this 50th year of political independence. Ever since the ball was set rolling on the path of liberalisation since 1992, trade in general and exports in particular have exhibited a boom showing very encouraging results. Yet the imports have always been more than the exports with the trade balance always being in the negative. Economic independence will only be achieved when our trade balance becomes positive or the exports exceeds the imports. Even though foreign exchange is pouring in through foreign direct investment, our real forex earnings can only come through exports. It is time to now think whether exports is really getting the priority it should actually be getting in order to attain economic independence.

The plastics industry has been registering good export growth rates of over 25 percent per annum in the past which has always been much above the growth rate of India's overall exports. In fact, even in 1996-97, when the overall exports registered a growth rate of barely 4 percent the plastics sector

exhibited an export growth rate of about 18 percent. The current year, however, has not been very encouraging with a negative growth rate from April of this fiscal year, which though has been showing an improvement month after month.

The reasons for the downward trend in the export growth rate has been attributed to many factors which on the international front include the recessionary tendencies worldwide, devaluation of currencies by competing nations and so on and so forth.

While the international factors have contributed to the decline in exports, there are many factors on the domestic front which have had an adverse effect on exports. The international environment could only act to retard the growth but the situation is not as bad as to produce a negative growth rate at least as far as the plastics sector is concerned. One of the main factors is the Exim Policy which did away with the VABAL and the Pass Book Scheme and introduced the DEPB Scheme. The Honourable Minister was kind enough to call a meeting of all the Export Promotion Councils to present an Export Strategy for the respective sectors. We had made it very clear that any new scheme introduced should be tried out before discontinuing the older schemes that had been tried out and almost stabilised. This aspect assumes more importance especially at a time when the exports were showing a declining trend and the international conditions were also not very conducive.

Even after the DEPB Scheme was announced, for nearly two months, the credit entitlement rates were not announced. After they were announced, to our utter surprise, we found that in case of plastics items the credit entitlements did not even cover the customs duties paid on the export inputs due to which the fate of the export trend in the coming months is still uncertain.

Looking back, I am inclined to believe that we lack a stable policy framework for maintaining the continuity of export operations and evolving a long range export strategy. Even though the liberalised Exim Policy 1992-97 was announced for a period of 5 years, the amount of changes it underwent in the 5-year period only proved that the validity of 5 years was only a paper announcement. The amendments being announced every year within the 5 year period was nothing short of a new policy announcement. Each innovative scheme being announced drew wide publicity in terms of the so called misuses pressurising the policy makers into further modifications adding to the instability of the policy. The concept of Exim Scrips was first introduced and later done away with. The VABAL was introduced, modified and finally deleted at a time when the scheme had stabilised and all avenues for misuse were plugged. The Pass Book Scheme also met with the same fate. Situations like these where an export promotion scheme is withdrawn when it has been successfully tried out and on the verge of being stabilised results in adverse impact on exports.

The time has come for us to do a great amount of introspection and actually examine the essence of liberalisation in the present context. At times, I am

inclined to believe that imports are becoming much easier and exports are becoming more complicated. During my tenure as the Chairman of the Council, I felt that any problem that we refer to the Government meets with the answer that exports shall not be held up. Well, I agree that exports are never held up but what is held up is the post export activities like logging of export entries, release of bank guarantees and the like. These are as important as according a smooth flow to the export cargo because it is only after such activities are successfully carried out that export activity maintains its continuity. In fact, encounters with post export activities that exhibit delays and uncertainties have made many a exporter from our sector shy away from exports and divert their efforts to the domestic market. If export activity is smoothened, I am sure we in the plastics sector will soon be producing to cater to the world markets rather than exporting the surplus capacities.

What then is the essence of liberalisation today? As far as the plastics sector is concerned, it should be ensured that duty free inputs are provided for export production. The modalities in availing such inputs should be free of all hassles. The main problem today is in view of the conflicting objectives of exports and revenue losses. I would like to impress upon you, Sir, that we are not advocating to let bad elements go scot free if they misuse any schemes. Please bring them to book. At the same time, take the trade into confidence while formulating the policies. The secretive attitude of the Government to keep the trade in suspense before the policies are announced are characteristics of a non-liberalised environment. Suggestions and views are invited from the Trade the fate of which is not known on most occasions. A lot of effort and brain-storming goes into compiling our suggestions and if we find that they are not considered without any convincing reasons the trade will be left with no option but to act upon to the best of its abilities within the policies and procedures thrust upon them. A strategic plan will not make any sense in such a case. If the trade is made a part of policy making, I am sure that many of the rich inputs that could be expected from the vast experiences of the trade.

The plastics sector barely enjoys any comparative advantages and is almost at par with the competing nations comprising mainly of the Asian Tigers. The export success lies in offering competitive prices which is largely possible only if we achieve the economies of scale. High technological inputs in terms of machinery is a must for achieving the economies of scale coupled with supply of plastic raw materials at international prices free from all hassles. It follows that the requirements of finances both in terms of working capital and investment in capital goods be made available at internationally comparable costs. The trends on the financial side are improving and I am sure, Sir, with the support of experienced administrators like you finances will no longer be a constraint in the future to come.

With regard to the peculiarities of the plastic sector - I would particularly like to touch upon three important aspects. The first is that the plastic processing industry - which commands a huge export potential - is dominated by the small scale sector. If a sizeable number of such units have to be motivated

into exports, it is imperative that plastic raw material be made locally available to them at international prices. Such units do not have the wherewithal to import container loads of raw materials and stock the same for export production. Further, the simplification of policies and procedures, particularly on the Customs and Excise fronts assumes greater significance. Such units certainly cannot afford a separate infrastructure to ensure compliance with the again suggesting that locally produced plastic raw materials can be supplied at international prices under the Duty Exemption Scheme if and only if all the benefits as applicable to physical exports are made available to such supplies for export production. Around 20 percent of the plastics exports comprise plastic raw materials which obviously will be exported at the ruling international prices. If the same material is diverted for processing at forex earning just by adding value to the plastic raw material which would have otherwise been exported. The other benefit through such a policy measure will be motivation to smaller units into entering the export arena.

The second point is the infrastructure. This point has been highlighted on many occasions both by our Council and the apex bodies. As far as the plastics sector is concerned, the role of power assumes a lot of significance since it forms a major input to the plastic industry. It is absolutely essential that efforts be made to supply power, the cost of which today is very high compared to our competing nations, at internationally comparable rates. It should also be ensured that uninterrupted power is also made available to the plastic industry which is a process industry.

And the last but not the least is the devaluation aspect - most of the competing nations like Malaysia, Indonesia and Thailand have devalued their currencies and the devaluation has been in the range of 25 to 40 percent. This has resulted in their exports being more competitive than ours the results of which are already showing on our export growth. In fact, Germany, which is considered one of the pioneers in plastics, also devalued the Deutsche Mark by about 20 percent in the last year. It is high time the Reserve Bank of India also evolves a plan to devalue the rupee gradually to enable us fight the international competition on an equal footing. Besides giving exports a greater thrust by evolving such a plan, the Government will also be able to collect better revenue on imports at a time when the revenue collection is also lagging far behind the target. Moreover, this will also result in giving some sort of protection to the domestic industry to grow better since the imports will become dearer and one may find local procurement more competitive.

The plastics sector enjoys a huge export potential. We talk about the high export volumes of countries like China, Taiwan etc. If we go into the details of their export composition we find that one of the sectors that dominate the composition is plastics. In contrast, the exports from the Indian Plastic sector is negligible. I take this opportunity to mention that against our annual consumption of 2 million tonnes of plastics we export only one lakh twenty five thousand tonnes which is about 6 percent of our annual consumption. In contrast, China which consumes about 10 million tonnes exports about 2.5

million tonnes of plastics which is much more than our annual consumption. This itself is an indicator of the vast export potential at our disposal which can be successfully tapped if a proper environment for export operations is provided. Our projections show that by the year 2000 we shall consume about 4 million tonnes of plastics and if we target an export of 25 percent of this consumption we shall be able to export about 1 million tonnes of plastics by the turn of the century.

I would like to add that a lot of responsibility and effort has to come from the trade to tap the huge export potential at our disposal. We have recognised the need to accelerate our marketing efforts and take lessons from our counterparts in the competing nations. The role of the Council becomes all the more important under such conditions. We are putting in efforts to make the PLEXCONCIL more effective both in terms of being of better service to members and supplementing their export efforts. In addition to our regular activities like attending to grievances of members, making representations to the Government and so on and so forth, we are also in the process of adding innovation to our activities like participation in trade fairs, dissemination of information etc. We are also contemplating a host of other activities. We are in the process of promoting electronic Commerce. As you are aware, our internet site is already operational and we are providing our members an opportunity to host their home pages at affordable costs. In fact, the list of all place in the Council is already in full swing. Consultancy services to members in terms of filing and follow up of Duty free Licenses, pre-shipment and post-shipment documentation etc are being envisaged in the near future. We are also looking into the possibilities of setting up warehouses in markets like the US where the tendency of the buyers today is to demand ex-stock deliveries due to which such facilities will soon become a part of the marketing strategies of hard core exporters in the future. Exhaustive market surveys after identification of thrust markets is also in the pipeline. We are also looking into the possibilities of identifying white goods industries in select countries to which supplies could be made through the Indian Plastics processing sectors.

I would also like to place on record, Sir, the immense co-operation and support being extended by your Ministry from time to time on various export-related matters and look forward to our working together with the common interest of promoting exports. On behalf of the Council and the Plastic Industry, I would like to assure you, Sir, that we will do our level best to bring in as much foreign exchange as possible through exports. We only expect a conducive atmosphere in which to operate. Again coming back to the essential features of liberalisation – we only expect that we get ample time to attend to the more important aspects like production and productivity, quality and marketing rather than get drowned with non-productive activities like logging of export entries, delays, harassment etc etc that we always talk about when we meet on such occasions. I am proud to mention that we in the plastics sector are bestowed with all the qualities essential for export success and shall not let you down if proper tools are made available to us.

Even though the export trends have not been very encouraging this year, I am hopeful they will be back on to the right trajectory very soon. I once again thank you very much, Sir, for accepting our invitation as a Chief Guest on this occasion. Your presence, I once again mention, Sir, is a source of inspiration for the exporting community particularly from the plastic sector. We do look forward to our continued interactions with you and your able team especially in evolving specific strategies to boost exports in general and exports of the plastics sector in particular.
