It gives me great pleasure to welcome you all today to this biennial Export Award Function which has always been a grand and memorable event for the PLEXCONCIL fraternity and its well-wishers and particularly the Export Award Winners.

I would like to accord a special welcome to Shri Suresh Prabhu the Honourable Minister for Chemicals and Fertilizers who has taken time out of his otherwise busy schedule and is amidst us here today to honour the Export Award winners. His presence here amongst us today is an indicator of his conviction to build the Indian plastic industry to become truly global in the future to come. I do look forward to his support, co-operation and guidance in our commitment to build capacities within our industry to service both the potential local and global markets.

I would also like to specially welcome all dignitaries from the Government who have always supported us in our ventures to move fast on the path of exports. A special welcome to my friends from the media who have always carried our messages and philosophy to the masses in the interest of export promotion.

All Export Award winners deserve a special welcome in consideration of their excellent performance despite the adverse environment both on the local and global fronts. It is worthwhile pointing out here that the aggregate export performance of the Export Award winners accounts for about fifty percent of the exports from the plastic sector. I am sure all other members will be motivated by these export award winners to achieve greater heights in exports and work towards becoming recipients of our Export Awards.

The Honourable Minister, I am sure, is aware of the characteristics of the plastic industry. Nevertheless, Sir, I would like to briefly touch upon

important aspects of this industry. This is an industry that is primarily driven by technology and raw materials and the success of this industry in becoming truly global lies in deployment of using world class technology to achieve economies of scale and efficient sourcing of raw materials. The industry does not enjoy any comparative advantages as compared to competitors overseas who by and large are the Asian Tigers. In fact, we are in a bit of a disadvantageous position in view of the infrastructural inadequacies in terms of movement of cargo within and out of the country, transactional costs and high cost of power.

As far as our exports are concerned, our industry has always been exhibiting a much higher growth rate in relation to the overall export growth rates from our country. However, the figures in the last two years have not been very encouraging. We achieved exports of 620 million US Dollars in 1997-98 and 514 million US Dollars in 1998-99 implying growth rates of about 7 and minus 17 percent respectively. However, while these growth rates are negative in value terms, in terms of quantity and value addition these are still positive since the raw material prices fell by around 20 percent resulting in lesser unit export realisations. Therefore, the performance needs to be commended. Our major markets have been the USA, United Arab Emirates, United Kingdom, Saudi Arabia, Belgium, Germany, Hong Kong, Sri Lanka, The Netherlands, Spain and France. In terms of Regional Blocks it has been North America, the European Union and the Middle East. The major products have been a wide range of plastic moulded and extruded goods, polyester film, raw materials, plastic woven sacks and fabrics, a range of writing instruments and decorative and industrial laminates. Human Hair and its products are also included under our Council and are among the top export exchange earners of the Council.

Our share in the world market is negligible and there is an immense export potential available at the disposal of the plastic industry. Based on the data available with the International Trade Centre, we analysed the exports of a few items manufactured in the Indian plastic industry which supported our belief of a potent export market. Plastic sacks/bags for example – the total world imports in 1997 were 3727 million US Dollars out of which India's share was about 9 million or just about 0.27 percent. India does not even figure among the top 15 suppliers of plastic sacks/bags. The world imported 2879 million US dollars worth of pens in 1997 out of which India supplied 20 million US Dollars or about 0.70 percent. At least in this item, India did figure out among the 15 top suppliers to some top importing countries. Plastic House/Toilet Ware world imports in 1997 were about 4408 million US Dollars and India's contribution was about 10 million US Dollars amounting to about 0.2 percent. It is worthwhile pointing out here that countries like Malaysia, Indonesia, Thailand and even Philippines figured as top suppliers to some importing countries. The potential of other items manufactured in the plastic sector is no different and with proper steps taken by the

industry and the right policy initiatives backed with simple and transparent procedures, I am sure that we could certainly achieve a respectable market share in the world markets.

While the reform process is on, I personally feel that there is much more to be done and has to be done at a real fast rate. If the industry has to grow, it has to be supported with a proper policy framework that will facilitate us to develop capacities to cater both to the local and global markets rather than exporting only surplus capacities. In fact, the plastic sector has developed capacities and capabilities in a few sectors that include polyester films and plastic woven sacks and fabrics. The capabilities built by us have resulted in the European Union targeting these sectors with anti-dumping and anti-subsidy proceedings. I also believe, that we do have capacities to add value to plastic raw materials by moulding and extrusion. However, past experiences have made some entrepreneurs shy away from exports and it is high time that exports are encouraged truly as is deserved for any subject of national priority.

The export policies should be so framed that all export inputs are exempted from taxes which include customs duty, excise duty, sales tax etc supported through hassle free procedures. Rightly all schemes under the Exim Policy aim at exempting export inputs from customs and excise duties. However, the Department of Revenue views such schemes as revenue losses which is the main cause for conflicting objectives between the Departments of Commerce and Revenue. While the Department of Commerce wants to promote the cause of exports through export promotion schemes aiming at tax free export inputs the Department of Revenue is more concerned with supposed revenue losses. These conflicting objectives result in denying schemes committed by one arm of the Government by another arm of the Government or by imposing more cumbersome procedures that virtually make an exporter feel harassed.

To quote an example – the present Exim Policy provides for a zero duty window for import of plastic machinery under the EPCG Scheme. However, till date this provision has not been made effective in the absence of a corresponding notification from the Department of Revenue despite the fact that zero duty EPCG licenses have been granted to many members of the Council. Those exporters who have made imports were not allowed zero duty clearance against the zero duty licenses held by them. The procedure of logging export entries in the DEEC books is so cumbersome that exporters who cannot afford to maintain a separate infrastructure for complying with such procedural requirements are bound to strike off exports as an agenda off their business plans.

While the Ministry of Commerce has been showing a lot of concern on these issues, many such issues remain either unresolved or are addressed after a very long span of time as a result of conflicting

objectives between the two arms of the Government. Such situations are demotivating factors to continue our march on the export path.

Another aspect that I would like to point out is with regard to exporters being answerable to so many Government Agencies on a single matter. For example with regard to export realisations and non-fulfilment of export obligations, exporters are answerable to several agencies i.e. DGFT, Reserve Bank of India, Customs department, DRI, enforcement etc. As a result, many a times they are treated like common criminals for not meeting certain requirements even if the situation is beyond the exporters' control. Such harassment naturally makes exports a high-risk low-return activity and results in exporters staying away from exports.

Such problems are being taken up by various Export Promotion Councils and apex bodies from time to time and solutions are really not forthcoming. The Ministry of Chemicals & Fertilizers being a functional Ministry for our sector has a larger objective to be fulfilled which in addition to exports includes building up the industry as a whole. Export friendly policies and procedures while adding to the export earnings of the country also add to build the industry, add capacities and generate employment by and large. As such, I earnestly request you, Sir, to take up the cause of exports with the highest levels in the Government hierarchy so that export operations are conducted in a friction-free environment. In this context, I look forward to also working very closely with your Ministry to both build the plastic industry and earn as much foreign exchange as possible through exports. During the course of our interaction we could identify many areas that cause friction to export operations and solutions to smoothen the same.

Before I could conclude, I would like to inform you, Sir, that we in the Council have identified that activities on the international front like export marketing and market surveys do deserve greater priority and proper strategies in this direction could possibly nullify our other weaknesses. As such, we are taking up promotional activities to conduct Market Surveys in target markets and have targeted the US to start with. We have been regularly sponsoring trade delegations and with the experience gained we have even decided to change the approach towards these visits. We have decided that we will conduct a brief market survey prior to the delegation visit by deputing a small team to get the pulse of the market. And we plan to add innovation to all our activities since we believe that there is always a better and more effective way to conduct our activities.

In our pursuit to achieve export excellence, Sir, we do look forward to your guidance and support and will consider it a great pleasure to work with you in your present capacity.
