Participation charges: Euro 477 /- per square meter under shell scheme with minimum bookable area of 9 square meters and upwards in multiples of 3 sq. meter. **Which include a constructed booth with fascia name, 1 table, 2 chairs, 2 spotlights and 1 power**

outlet. Corner stalls will be of minimum 21 sqm and would be charged at 15% premium. The invoice would be raised based on the exchange rate of that date.

Benefit to the participants :

MAI benefit restricted maximum up to 72 sq. meter area to an individual participant-participation charges of **Rs. 10,000/-per sq. meter** will be reimbursed to the eligible PLEXCONCIL member participant. & for **Non-Members of the Council a sum of Rs.8,000/-per sq. meter** only after submission of **outcome report** on completion of their participation; with self-certified copy of IEC; proof of travel- **e-ticket** and (self-certified copy Indian passport (page 1st & last) & other pages with immigration stamps showing arrival & departure in India & Germany or boarding passes) of the firm's representative who must be a proprietor, partner, director or employee of the company. **This refund will be made only on receipt of funds from the Government.** In view of limited funds available under MAI, reimbursement will be on a first-cum-first-serve basis to the extent of our budget.

Payment schedule: 50% non-refundable payment along with application and Balance payment of 50% must be paid before 30th June 2019.
