**Sub: Regarding reporting of Anti Dumping cases / non-tariff barriers faced by the Industry / Exporters**

We wish to inform you that the Ministry of Commerce had organized a meeting recently wherein they discussed and have sought information from the exporters about any new cases of Anti-Dumping (AD) investigations / Non – tariff barriers that have been initiated against the products being exported by them.

In this connection, the council has already circulated similar information vide circular ref. : Plexh/Cir/0187 dated 27.05.2019. In this circular it was requested that the Trade Defence Wing in Directorate General of Trade Remedies is in the process of analyzing the Anti-Dumping investigations conducted by different investigation Authorities against Indian Exporters / Domestic Industry. This exercise is being undertaken to understand the procedures followed by the other Investigating Authorities and to see if are they complying with the WTO norms or not.

In view of the above members are requested to inform the council about any present ongoing AD investigation/ Non –tariff barrier as per the attached proforma on or before 15.06.2019 at [bharti@plexconcil.org](mailto:bharti@plexconcil.org). **This is a great opportunity for all members exporters of the council to highlight all AD cases before the competent authority for its redressal.**

Members are also requested to keep the council informed of similar Anti-Dumping investigations / non-tariff barriers being faced by them on a regular basis so that the same can be shared with Directorate General of Trade Remedies for timely redressal.
