**Subject : Meeting of the Working Group on Export Promotion and Facilitation.**

We wish to inform you that Central board of Indirect Taxes and Customs (CBIC) has constituted a Working Group on Export Promotion and Facilitation under the Chairmanship of Shri O. P Dadhich, Chief Commissioner of Customs, Delhi Zone, New Delhi. The group is mandated to look into issues being faced by exporters on various aspects as below :-

- a) Customs procedures and facilitation
- b) Impact of FTA's signed by India
- c) Tariff concessions vis-à-vis non-tariff barriers faced by exporters in export markets.
- d) Need for non- preferential rules of origin and their structure
- e) Quality /cost of services providing by various intermediaries in the Customs environment like Customs brokers, shipping lines, forwarders, custodians, etc
- f) Facilitation of e-commerce exports
- g) Manufacture – in – bond section 65 of the Customs Act
- h) Any other export related issue.

The Working Group is holding a meeting on 05.04.2019 in Mumbai with certain ECPs including our Council to discuss various issues being faced by exporters on aforesaid issues and to invite their suggestion on export related issues. Member (Tax Policy) and CBIC will also interact during the meeting with EPC's.
