Plastics trade between India and CIS

India's plastics exports to the CIS countries is valued at USD 93.8 million (2017).

Russia is the top-most destination, followed by Ukraine and Georgia. Together, these three countries are responsible for 89% of all plastics exports from India to CIS.

Based on the data sourced from ITC-TradeMap, it was found that CIS undertakes annual imports of plastics worth USD 20-22 billion from the world and with annual exports of USD 85-95 million of plastics products from India to CIS, our market share in CIS is below 0.5% which needs to be enhanced.

Deeper analysis reveals that the indicative trade potential for export of plastics products from India to CIS was highest in product categories like Plastic raw materials; Plastic sheets,

films, plates etc; Packaging items; Other moulded and extruded items; and Medical disposables. Complete details are provided on next page.
