AEO is a flagship programme of Ministry of Finance, Govt. of India. In order to focus on “Ease of doing Business”, the comprehensive new AEO programme has been further substantially simplified for importers and exporters. The earlier AEO T1 application consisting of seven Annexure has been simplified and rationalized to only two Annexures vide Circular 26/2018-cus dated 10.08.2018.

In light of above, this Academy would conduct an interactive session and workshop on ‘Authorised Economic Operator’ on 16.11.2018 for the member exporters of various council’s .
