As members are already aware that Regional Comprehensive Economic Partnership (RCEP) is a free Trade Agreement being negotiated involving 16 countries namely ten countries of ASEAN (Brunei, Cambodia, Indonesia, Laos, Malaysia, Mayanmar, Philippines, Singapore, Thailand, and Vietnam) and their six free trade agreement (FTA) partner i.e Australia, China, India, New Zealand and South Korea. The RCEP negotiation have entered a critical stage having completed 5 years which was aptly captured by the 2nd RCEP Leader's Summit communiqué held on 14th November, 2018 in Singapore acknowledging a substantial progress in the negotiation. RCEP countries count for 32 percent of global GDP and 28 percent of global trade. From India's point of view, RCEP is a natural extension of India's Act East Policy with long term strategic interests in the integrating Indo-Pacific region.

Department of Commerce, GoI has entrusted the center for Regional Trade (CRT) to undertake an independent assessment of India approach in the RCEP negotiations through stakeholder's consultation across the country on tariff modalities. Accordingly, one Day Stakeholder's consultation meeting is organized of various stakeholders from the State to gather inputs with respect to the trade in goods commitments that India should look for in its negotiations. In this regard there is as Stakeholder's Consultation meeting in Mumbai on 28th February 2019. Our council will be representing the Plastic industrires in this meeting.
