Sub : Option to close cases of default in Export obligation.  
Ref. : 01/94/180/395/AM13/PC-4/259

Please note that DGFT is in the process to close all old pending Advance Authorisation and EPCG cases, an opportunity to close cases of default in Export obligation, similar to the one given in 2013.

Under this one time relaxation scheme, an option to pay interest equal to the applicable customs duties corresponding to shortfall in Export Obligation for both AA and EPCG authorization for regularization purpose. Similar exercise has been undertaken by DGFT in past, details are given below :-
