**Subject: Participation in INTERPLASTICA MOSCOW-2020, Moscow, Russia –28 to 31, January, 2020.**

Dear Sir(s),

We have pleasure in informing you that the Council is organizing Indian participation at the **INTERPLASTICA MOSCOW-2020** exhibition, scheduled to be held between **28-31 January, 2020** at Expocentre Fairgrounds, Krasnaya Presnya, Moscow. This activity is being carried out with financial support from the Department of Commerce, Government of India, under the Market Access Initiative (MAI) scheme. The event is organized by Messe Dusseldorf GmbH, details of which can be viewed at: [www.interplastica.de](http://www.interplastica.de)

The global import of plastics (Ch. 39) by Russia is over USD 9.0 Billion and our share of the Russian market is less than 0.5%, which shows the huge potential this market has to offer.

#### **Plastic Products having a good export potential to Russia:**

Polyester Films, Tableware & Kitchenware, Woven sacks/FIBCs, Tooth brushes, Other Household & toilet articles, Medical Disposables, Masterbatches, Caps and Closures, Ball Point Pens, Floor coverings, Leather Cloth etc.

**Participation charges: Independent Booth:** **Rs.32000/-per square meter** with minimum bookable area of 12 square meters. In addition to this, there is a Registration fee of **Euro 490/- per exhibitor**. Each 12 sqm constructed booth includes carpet, fascia name, 1 table, 2 chairs, 2 spotlights and 1 power outlet.

The organizer also offers a Premium Package with minimum bookable area of 18 square meters. The charges for the same would be **Rs. 36000/- per square meter**. For a corner stand with two sides open, an additional surcharge of **Rs. 2800/- per square meter**, would be applicable. Registration fee of Euro 490/- per exhibitor would also be applicable. Each 18 sqm constructed booth under the Premium Package includes carpet, fascia name, 1 table, 4 chairs, one sideboard, lockable cabin, 1 coat rack, 1 waste paper basket, 4 spotlights and power connection.

**Participation charges in Council's Common Area Pavilion:** Total participation charges of **Rs. 2.40 lakhs** (including registration charge of Euro 490/- per exhibitor) shall be charged in the Council's Common Area Pavilion per exhibitor. Each exhibitor shall get 6 square meters space which shall include carpet, 1 table, 1 chair, 1 spotlight.

**Payment schedule:** 50% non-refundable payment along with application & balance 50% on or before 25<sup>th</sup> October, 2019. Payments must be made through at par cheques/demand draft payable at Mumbai and drawn in favour of **THE PLASTICS EXPORT PROMOTION COUNCIL**.

**Benefit to the participants: Subsidised Space under MAI Scheme :** MAI benefit restricted maximum up to **12 sq. meter area** to an individual participant-participation charges of Rs. 8000/- per sq. meter will be reimbursed to the eligible PLEXCONCIL member participant, and for Non-Members of the Council a sum of Rs.7000/- per sq. meter will be reimbursed, only after submission of outcome report on completion of their participation, with self-certified copy of IEC; proof of travel- e-ticket, self-certified copy of Indian passport (1st & last page & other pages with immigration stamps showing arrival & departure in India & Russia or boarding passes) of the firm's representative who must be a proprietor, partner, director or employee of the company. This refund will be made only on receipt of funds from the Government. In view of limited funds available under MAI, reimbursement will be on a first-cum-first-serve basis to the extent of our budget. **The re-imburement amount is only indicative and may vary on the basis of number of participants and grant released by the government for the event.**

***Air Fare:*** In addition to the above, **Economy Class Air fare will be reimbursed** to the eligible participating members of PLEXCONCIL, as per MDA guidelines (strictly on first-cum-first-served basis, maximum upto 30 Members) of the previous MDA scheme & it will be provided subject to Government's approval and only after receipt of funds from the Government. Only those participating members of Plexconcil who are a regular Director, Partner or Proprietor of their firm having exports of FOB value upto Rs. 30 crores in the preceding financial year would be eligible for air fare reimbursement (provided they satisfy other conditions of the previous MDA Scheme).

***Application:*** Interested members are requested to confirm their participation by sending attached application form duly completed along with 50% non-refundable advance payment.
