As you are aware, payments pertaining to Iran Trade are facilitated in INR mainly through UCO Bank which is one of the Nodal Banks designated by the government. However, exporters have also reported issues while transacting through UCO Bank.

In this regard, recently we in joint association with Chemexcil have been approached by Trade Finance Dept, IDBI Bank Ltd, Mumbai who have also offered to facilitate India-Iran Trade Settlements in INR.

To further address member's queries, if any, on the modus operandi of Iran transactions through IDBI Bank, the council has organized interactive sessions in Mumbai & Ahmedabad, respectively, with Senior Officials of IDBI Bank who are handling Iran Trade mechanism.
