Subject: Participation at JEC World 2020, Paris March 03 – 05, 2020

We have pleasure in informing you that the Council is organising India Pavilion at **JEC World 2020**, scheduled to be held in Paris-Nord, France from March 03 – 05, 2020.

Market Overview:

France is the 6th largest economy of the world with a total GDP of \$ 2.78 trillion in 2018 & a GDP growth rate of 1.7% in 2018. It is one of the largest countries and main economy in Europe. In terms of purchasing power parity France is the third largest economy in Europe and tenth largest economy in the world. France ranked 8th largest exporter and 6th largest importer in 2018, as per Trade Map. Its technological strengths make it the leader in sectors such as aviation, space, food processing, transport, railways and agricultural research.

In 2018, India-France bilateral trade stood at \$ 11.94 billion. India's exports to France were valued at \$ 5.20 billion, while its exports from France were valued at \$ 6.73 billion resulting in a trade deficit of \$ 1.53 billion to India. Within plastics, India's position is seemingly strong with plastics exports worth \$ 224.51 million to France and a trade surplus of USD 34.29 million to India.

India's plastics exports to France largely comprise of: All types of optical items (50.7%); Woven sacks/FIBCs (18.6%); Packaging items (8.8%); Plastics sheets, films, plates etc (5.8%); and Plastics raw materials (5.4%).

The plastics demand in France reached 5 million tons, which represents 9.6% of the European plastics demand (47.8 million tons) after Germany (24.9%) and Italy (14.3%). France is 3rd largest converter of plastics in Europe which creates an immense potential for the India Plastics Industry for Exports in this region. The major convert demand in France are used in Packaging, Building & Construction, Automotive, Electrical & Electronic, Household & Agriculture.

JEC World 2020 is one of the largest trade fairs for Composites Plastic Industry in the world and is well attended by all stakeholders of the Global Composites industry. Since years the exhibition is providing a unique platform for the composite plastics industry to explore business opportunities not only in Europe but globally.

Benefit to the participants: Subsidized Space under MAI Scheme: Subsidy under MAI scheme is available as per the Government guidelines. The participation charges of Rs.13000.00 / sqm will be eligible for Plexconcil member participants & for Non-Members of the Council a sum of Rs.11500/-per sq. meter will be reimbursed, only after submission of outcome report on completion of their participation, with self-certified copy of IEC; proof of travel- e-ticket, self-certified copy of Indian passport (1st & last page & other pages with immigration stamps showing arrival & departure in India & France or boarding passes) of the firm's representative who must be a proprietor, partner, director or employee of the company. This refund will be made only on receipt of funds from the Government. In view of limited funds available under MAI, reimbursement will be on a first-cum-first-serve basis to the extent of our budget. **The re-imburement amount is only indicative and may vary on the basis of number of participants and grant released by the government for the event.**

Air Fare: In addition to the above, **Economy Class Air fare will be reimbursed** to the eligible participating members of PLEXCONCIL, as per MDA guidelines (strictly on first-cum-first-served basis, maximum upto 25 Members) of the previous MDA scheme & it will be provided subject to Government's approval and only after receipt of funds from the Government. Only those participating members of Plexconcil who are a regular Director, Partner or Proprietor of their firm having exports of FOB value upto Rs. 30 crores in the preceding financial year would be eligible for air fare reimbursement (provided they satisfy other conditions of the previous MDA Scheme).
