Subject : Developing Districts as Export Hub Initiative - RA Mumbai Action Points/Feedback

We have received communication from O/o Addl. DGFT Mumbai regarding Developing Districts as Export Hub Initiative of DGFT, Department of Commerce where District Export Promotion Committees (DEPC) are being formed and notified in each Districts.

DEPCs have been mandated to identify focus Products/Services based on their Export Potential in the District and to prepare a District Export Action Plan which should be adopted by each District latest by 31st December 2020.

In this regard, it is informed that 1st meeting of such DEPCs have been held in many districts and a brief draft District Export Action Plans have been discussed in such meetings.

As discussed in DEPC meetings by members, it is expected that various action points suggested may be of nature which could be resolved at District Level including the low hanging fruits. Some of the illustrative examples, but not limiting ones, are -

- Requirement of any Road /Over-Bridge Construction /De-Congestion
- Electricity/Public Transport related issue
- Requirement of any Testing/Certification Facilities
- Identifying Clusters and help regarding their recognition and related benefits
- Building or Strengthening any Common Facility Centers
- Any specific procedural/form simplification or Training/Mentoring needs etc.
