**Subject : Amendment of Importer-Exporter Code (IEC) related provisions under Chapter-1 and Chapter-2 of Foreign Trade Policy, 2015-2020**

We wish to inform you that the O/o Directorate General of Foreign Trade, New Delhi has issued Notification No. 58/2015-2020 dated 12th February, 2021 regarding Amendment of Importer-Exporter Code (IEC) related provisions under Chapter-1 and Chapter-2 of Foreign Trade Policy, 2015-2020.

As an effect of this Notification, IEC related provisions in Chapter-1 and Chapter-2 of Foreign Trade Policy, 2015-2020 are amended/deleted and new provisions inserted. **Further, it is provided that an IEC holder has to ensure that details in its IEC is updated electronically every year, during April-June period.** In cases where there are no changes in IEC details same also needs to be confirmed online. An IEC shall be de-activated, if it is not updated within the prescribed time. IEC so de-activated may be activated, on its successful updation. This would however be without prejudice to any other action taken for violation of any other provisions of the FTP.

As per the notification, following paragraphs of Foreign Trade Policy, 2015-2020 are amended as below:

<p><b>1.11 Issue of e-IEC (Electronic- Importer Exporter Code)</b></p> <p>(a) Importer Exporter Code (IEC) is a mandatory for export/import from/to India as detailed in paragraph 2.05 of this Policy. DGFT issues Importer Exporter Code in electronic form (e- IEC). For issuance of e-IEC an application can be made on DGFT (<a href="http://:dgft.gov.in">http://:dgft.gov.in</a>). Applicant can upload the documents and pay the requisite fee through Net banking. Applicant shall, however, submit the application duly signed digitally.</p>	<p><b>1.11 e-IEC (Electronic-Importer Exporter Code)</b></p> <p>Importer Exporter Code (IEC) is mandatory for export/import from/to India as detailed in paragraph 2.05 of this Policy. DGFT issues Importer Exporter Code in electronic form (e-IEC). Application for issuance of e-IEC can be made directly on the DGFT web portal (<a href="https://www.dgft.gov.in">https://www.dgft.gov.in</a>).</p>

The following sub-paragraphs are inserted under para 2.05 of Chapter-2 of Foreign Trade Policy, 2015-2020 as under:

**FTP Paragraph no. 2.05(d)** - An IEC holder has to ensure that details in its IEC is updated electronically every year, during April-June period.

An IEC shall be de-activated, if it is not updated within the prescribed time.

In cases where there are no changes in IEC details same also needs to be confirmed online.

**FTP Paragraph no. 2.05(e)** - IEC so de-activated may be activated, on its successful updation. This would however be without prejudice to any other action taken for violation of any other provisions of the FTP.

**FTP Paragraph no. 2.05(f)** - An IEC may be also be flagged for scrutiny. IEC holder(s) are required to ensure that any risks flagged by the system is timely addressed; failing which the IEC shall be deactivated.

**The subparas 1.11(b), 1.11(c) and 1.11(d) of Foreign Trade Policy, 2015-2020 are deleted.**

Members are requested to take note of above IEC related amendments and do the needful accordingly to avoid any issues. The said DGFT Notification is available for reference on below link-
