We are pleased to inform you that The Plastics Export Promotion Council is organising a webinar on Production Linked Incentive (PLI) Scheme for Technical Textile such as **FIBC bags, Nets; Ropes, twines, cordage and others**. The scheme is expected to be announced by the Government of India shortly. The Government has allocated an outlay of INR 10,683 crores for Man-made fibres (MMF) and Technical textiles.

The intent of the PLI scheme is to promote domestic manufacturing, increase exports and encourage import substitution for about 40 products in the MMF category and 10 in the Technical textiles category. The eligibility under the PLI scheme is based on criteria's like investment / manufacturing capacity / turnover.
