With reference to the above, we understand that you have requested the Human Hair and Hair Products Manufacturers and Exporters Association of India (Henceforth referred to as Human Hair Association) for price guidance for articles related to Human Hair and Hair Products.

Based on the information and the invoices provided by the export members, we are giving the market rates for the previous quarter below. These rates seem to mirror the prevailing market rates as of Q1 2021.
