**Subject : Regarding inviting Pre-Budget Proposals for the Year 2022-23**

We wish to inform you that Department of Commerce (Trade Finance Section) seeking inputs on Pre-Budget Proposals for the Year 2022-23.

With this, Export related Pre-Budget Proposals for Pre-Budget Exercise of the Union Government for the year 2022-23 are invited in duly filled up prescribed Proforma — I & II (attached herewith).

Kindly also consider following points while preparation/ submission of your pre-budget proposals:

\*Budget Proposals should be complete in all respects, properly categorized and HS Codes for each commodity must be provided.

\*Justification given infavour of the proposals shall be restricted to 300 words and Annexures should be used, if necessary.

\*Issues discussed year after year but never agreed to, may not be raised again.

\* In view of the fiscal crisis, proposals of small reduction/exemption in custom/ excise duties, service tax etc. should be avoided unless they are absolutely necessary if such reduction/exemption are necessary, then ample justification should be given.

\*Where temporary relief has been given to some sector for particular period (i.e. upto 31.03.2022), then it should be re-examined and views may be submitted on these as well.
