Further, under the EPR The following plastic packaging categories are covered under EPR:

**(i) Category I - Rigid plastic packaging**

**(ii) Category II - Flexible plastic packaging of single layer or multilayer (more than one layer with different types of plastic), plastic sheets or like and covers made of plastic sheet, carry bags (including carry bags made of compostable plastics), plastic sachet or pouches and**

**(iii) Category III - Multi-layered plastic packaging (at least one layer of plastic and at least one layer of material other than plastic)**

**The EPR regulation covers the following with respect to plastic packaging:**

**I. Reuse**

**II. Recycling**

**III. Use of recycled plastic content**

**IV. End of life disposal**
