imported products under the WTO Agreement if the importing country finds that an exporting country exports the products with improperly-lowered prices or dumped prices and that the dumped products cause material injury to the domestic industries of the importing country. Through such measures, the importing country corrects the dumped price to the correct price in the country and gives a level playing field to the domestic industry.

In recent years, global economies are facing fiercer business competition, excess production and other international challenges. Against this backdrop, a growing number of countries have been making use of AD measures in order to re-establish fair competition environments.
