In reference to the above subject, we wish to inform you that the Common digital platform for issuance of Non-Preferential Certificate of Origin(CoO) has been introduced & expanded by the O/o DGFT which is available at <https://coo.dgft.gov.in/>. The objective of this platform is to provide an electronic, contact-less single window for the CoO related processes. We have been further informed that PLEXCONCIL's online application module has been made live & it is now ready to accept application.

In view of the same, members are informed that the applications for Non Preferential Certificate of Origin must be submitted through the aforesaid link by selecting our Council's Name "The Plastics Export Promotion Council" as the issuing authority while filing your CoO application. Thereafter it will be processed from the Common Digital Platform and member exporters will be able to download the same.

As per above Trade Notice, the transition period for mandatory filing of applications for Non-Preferential Certificate of Origin through the e-CoO Platform has been extended till **31st January 2022**. Member exporters who have not registered on Common Digital Platform are requested to register and move to the aforesaid platform at the earliest
