Subject : : Request for comments/data on issues/anomalies, if any, arising out of changes incorporated in RoDTEP and Drawback schedules consequent to their alignment with Customs tariff.

We wish to inform you that the Central Board of Indirect Taxes & Customs (Drawback Division) are seeking comments/data on issues/anomalies, if any, arising out of changes incorporated in RoDTEP and Drawback schedules consequent to their alignment with Customs tariff.

Consequent to Finance Act, 2021, Government of India has notified the Customs Tariff of India, 2022 (CTI, 2022) which came into effect from 01.01.2022

Consequently, to ensure seamless filing of export documents which may include claims for Drawback/Remission of Duties and Taxes, the existing schedules under RoDTEP and Drawback schemes were amended to align them with CTI, 2022 and have been implemented in the Customs Automated System with effect from 01.01.2022. The changes in the Drawback Schedule have also been notified vide Notification No. 108/2021 Customs (N.T.) dated 31.12.2021 (<https://www.cbic.gov.in/resources/htdocs-cbec/customs/cs-act/notifications/notfns-2021/cs-nt2021/csnt108-2021.pdf;jsessionid=01AE23D605487F135FD15E66C24C97B5>)

In this regard, members are requested to provide their comments/data w.r.t. any anomalies/errors that they may have noticed in the RoDTEP/Drawback Schedules arising from said realignment with the CTI,2022.
