**Subject:- REGARDING DGFT AMENDED THE REQUIREMENT OF E-BRC FOR CASES OF EXPORT TO OFAC LISTED COUNTRIES**

**Ref : DGFT Notification no- 50/2015-2020 Dated 17<sup>th</sup> March ,2022**

We you are aware that the requirement for redemption of Advance Authorisation (**Chapter 4**) exporters are required to submit eBRC for Redemption / EODC purpose. However, it becomes difficult when export is to OFAC listed Countries (Balkans, Belarus, Burma, Cote D'Ivoire (Ivory Coast), Cuba, Democratic Republic of Congo, Iran, Iraq, Liberia, North Korea, Sudan, Syria, and Zimbabwe)

Now, vide the above mentioned amendment, DGFT has provided option to submit FIRC along with Self declaration for export to OFAC listed countries where eBRC could not be generated by concerned bank.

In case of export to OFAC listed countries, exporter may submit FIRC along-with the self-declaration that e-BRC could not be generated by the concerned bank.
