We would like to draw your attention to our circular Plexh/Cir/2021-22/768 22nd March 2022 regarding Issuance/Renewal/Amendment of Registration cum membership Certificate through Common Digital Platform of DGFT. In reference to the same members are hereby informed that the RCMC processes are live on the DGFT portal and members may renew their RCMC via Common Digital Platform. Members may also note that those who will initiate the NEFT payment to Council on or after 01.04.2022 will have to apply online on DGFT portal and update the payment details in renewal application as it is mandatory to file the renewal application via common digital platform wef 01.04.2022.

Further, members are also informed that the issuance of Certificate of Origin Non-Preferential) is mandatory from Common Digital platform of DGFT wef 01.04.2022 vide Trade Notice No. 32/2021-22 dt. 24th January, 2022.
