**Subject : Regarding extension/ deferment of Control order for Polyethylene Material for Moulding and Extrusion - IS 7328: 2022.**

This has reference to our earlier circular ref. No. Plexh/Cir/ 410/dated 11.10.2021 regarding extension / deferment of above mentioned control order, we further would like to inform you that the Central Government, after consulting the Bureau of Indian Standards has passed the amendment and further extended the date of implementation of Quality control order 2022(IS 7328:2022).

It shall come into force on the 3<sup>rd</sup> October, 2022.

It shall apply to goods or article specified in column (1) of the Table below and shall not apply to such goods or article meant for exports.

Conformity to standards and compulsory use of Standard Mark – Goods or article specified in column (1) of the below table shall conform to the corresponding Indian Standard given in column (2) of the said Table and shall bear the standard mark under a licence from the Bureau of Indian Standards as per Scheme – I of Schedule – II of the Bureau of Indian Standards (Conformity Assessment) Regulations, 2018.

Certification and enforcement authority – In respect of the goods or article specified in column (1) of the said table, the Bureau of Indian Standard shall be the certifying and enforcing authority.
