- May Illuminating office Buildings in Tri-color and may also encourage their partners, ancillary units, dealer networks etc. to do the same.
- Publicity Events such as Marathons etc, promoting the campaign can be organized by Corporate Groups.

- Publicity of Har Ghar Tiranga Campaign via hoardings, Posters, Wall paintings, etc on Premises of The offices

- **Members** to issue suitable directives to all employees to Pin the Flag on Website and upload Selfie with Flag on the Website/Social Media Platforms
- Changing DP on social media accounts of individuals
