We have pleasure in informing you that the Council is organizing India Pavilion at <u>The Big 5</u> <u>Dubai</u> scheduled to be held in Dubai World Trade Centre, UAE from 5th-8th December, 2022.

In 2021, India and the Middle East region engaged in bilateral trade worth USD 170 billion. Within plastics, India's exports to the Middle East region were valued at USD 1.89 billion in 2021. India's plastics exports to the Middle East region primarily comprise of Plastic raw materials (48%), Plastic films & sheets & (13%), and Consumer & houseware products (8%). However, Middle East region's annual plastics imports are valued at USD 57 billion approx. and India's share in its imports is quite low. India's value-added plastics export to the Middle East region has the potential to grow by USD 6.3 billion.
