Subject : Regarding DGFT – Regional Office Mumbai special drive for removing shortcomings in the Redemption/EODC applications.

As members are aware that DGFT, RA Mumbai has re-structured and rationalized Sections in November 2022, to enable faster processing of applications of Redemption / Export Obligation Discharge Certificate (EODC) for Advance Authorization and Export Promotion Capital Goods (EPCG) Schemes. The provisions of Foreign Trade Policy (FTP) and Hand Book of Procedures (HBP) which outline the necessary compliances required for getting the Redemption/ Export Obligation Discharge Certificate (EODC) of any advance authorization and EPCG schemes are in the public domain, and are readily available at the portal wwv.dgft.gov.in.

However, as per RA Mumbai office analysis the applications made has revealed that certain application lack the proper document required for Redemption/ Export Obligation Discharge Certificate leading to the issuance of Deficiency Letters thereby resulting in delayed processing and issuance of Redemption/EODCs.

Further, it has been noted that many of the these deficiencies are common and are being observed in applications from different applicants. Based on the experience of Mumbai RA office, Scheme-wise common shortcomings have been identified and are listed in Annexure-A for Advance Authorization and Annexure-B for EPCG Authorization.

This drive will expedite the processing of Redemption/EODC cases and allow the RA Mumbai to provide the service of issuing the due Redemption/EODCs expeditiously in the ongoing Special Drive for substantive liquidation of pendency.

Members those who are taking service from DGFT RA Mumbai office are requested to refer both the Annexures in order to close their Advance authorisation and EPCG authorisation without any deficiency.
