This scheme covers the Advance Authorization Scheme (all variants) and EPCG Scheme (all variants), in the following manner:

- (i) Authorizations issued under Foreign Trade Policy 2009-14 from 27.08.2009 till 31.03.2015.
- (ii) Authorizations issued under Foreign Trade Policy 2004-2009 and before, wherein the Export Obligation period (Original or Extended) are valid beyond 12.08.2013.

Members please note that this is a golden opportunity for Authorization Holders to regularize their cases who have defaulted in completion of EO as under this scheme the interest payable on the Customs Duty will not exceed the amount of exempted Custom Duty. Further, there is no interest payable on the portion of Additional Customs Duty and Special Additional Customs Duty.

In this regard O/o. Addl. DGFT, Mumbai has organized the meeting under the Chairmanship of Additional DGFT, Mumbai wherein the discussion on trade issue (related with Mumbai RA- DGFT) with regard to Amnesty Scheme will be done.
