Subject: URGENT / IMPORTANT: Regarding Amnesty Scheme for Advance Authorization and EPCG Scheme

With regard to "Amnesty Scheme for Advance Authorization and EPCG Scheme", it was informed that this is a one-time opportunity for which the deadline to register on the DGFT portal is 30.06.2023. All the information about the Scheme is available at the DGFT portal through Public Notice No. 2/2023 dated 1st April 2023 read with Public Notice 7/2023 dated 18th April 2023 and Policy Circular No. 1/2023-24 dated 17.04.2023.

It may be noted that **the deadline i.e. 30.06.2023 is for registration** and once the applicants register their intent to avail amnesty Scheme, RA concerned would be giving further direction/communication to the applicants for duty payment under Amnesty Scheme.

You are requested to check all the Advance authorization or EPCG and do the needful as per the attached guideline Or in case of any difficulty please contact to the undersigned.

DGFT ALLOWS MANUAL MODE SUBMISSION FOR AMNESTY SCHEME DOCUMENTS- RECENT UPDATE

In view of certain problems faced by some exporters, DGFT has allowed manual mode with application being filed online on a standalone website: http://www.amnestyscheme.in

The Applicant is required to file the form online on this website: http://www.amnestyscheme.in record the reason for not able to file online on the main DGFT website in "Remarks"

The Applicant then must take print of the filled form, signed by Authroised Signatory and arrange the submission prior to the deadline (i.e 30.06.2023) to the Regional Authority.

The Application received manually, will be processed by RA and shortfall may be communicated via letter.

On receipt for the duty payment challan RA will finally close the EODC on the online module only.

Subject : Regarding Amnesty Scheme for Advance Authorization and EPCG Scheme
We wish to inform you that the DGFT <u>Public Notice No. 2/2023 dated 1st April 2023</u> read with <u>Public Notice 7/2023 dated 18th April 2023</u> and <u>Policy Circular No 1/2023-24 dated 17.04.2023</u> has announced an "Amnesty Scheme for One Time Settlement of Default in Export obligation by Advance and EPCG Authorization holders".
 This scheme covers the Advance Authorization Scheme (all variants) and EPCG Scheme (all variants), of the following categories:
(i) Authorizations issued under Foreign Trade Policy 2009-14 from 27.08.2009 till 31.03.2015.
(ii) Authorizations issued under Foreign Trade Policy 2004-2009 and before, wherein the
Export Obligation period (Original or Extended) are valid beyond 12.08.2013.
2. Benefit allowed under the Scheme: If you have defaulted in meeting the Export Obligation (EO), partially or fully of Authorization(s) then you make regularize the same by making payment of all applicable Customs Duties that were exempted with respect to your Authorization issued in proportion of unfulfilled EO and interest payable thereon provided the interest value shall not exceed 100% amount of the exempted duty applicable. Also, you are not required to pay the interest on the portion of Additional Customs Duty and Special Additional Customs Duty. May note that any penalty liable under FT(D&R) A has also been waived off, for authorization holders opting for the Scheme.
3. Procedure for Registration & Application ; For applying under the said Scheme subject to provisions of the Amnesty Scheme, Authorization(s) holders are requested to refer to Policy Circular No. 1/2023–24 dated 17.04.2023 , wherein the filing of the online application has been prescribed which is reproduced here below for your convenience:
(i) Application for Advance Authorization/ EPCG discharge/ closure shall be filed online by logging onto the DGFT website and navigating to the services-à Advance authorizations/ DFIAà Closure of Advance authorization. For EPCG please navigate to servicesà EPCG-à Closure of EPCG.
(ii) The Applicant shall select the checkbox for "Amnesty Scheme for One Time Settlement of Default in Export obligation" and proceed to file a application for closure against the concerned EPCG or Advance Authorization(s) as per the online proforma.
(iii) For further guidance, please refer to the Help Manual on DGFT website-à Learn-à Application help & FAQs -à Advance Authorization Closure Help document or EPCG Help Document.
4. Validity of the Scheme: The benefits of the scheme can be availed by registering as per above mechanism on or before 30.06.2023 and payment customs Duty plus interest should be completed by 30.09.2023.
5. This is a golden opportunity for Authorization Holders to regularize their cases who have defaulted in completion of EO as under this scheme the interest payable on the Customs Duty will not exceed the amount of exempted Custom Duty. Further, there is no penalty and also interest payable on the portion of Additional Customs Duty and Special Additional Customs Duty is not required to be paid.
