**It may please be informed that T-PLAS 2023** is the region's dedicated platform to tap into the vibrant marketplace of Thailand. Driven by demand in the vigorous domestic economy, it continues to strengthen its role as a leading global hub of plastics manufacturing with a greater emphasis placed on value-added and technologically advanced products. Running in parallel with T-PLAS 2023 is PACK PRINT INTERNATIONAL, the International Packaging and Printing Exhibition for Asia, and CorruTec ASIA, the International Corrugated Technology Exhibition for Asia. We have been informed that the strategic co-location will sharpen the profile and enhance the relevancy of the three independent trade fairs. **Trade Potential:** As Thailand imports plastics worth USD 14.5 billion from the world, there is immense potential for India to further increase exports of articles like Plastic films and sheets; Consumer & houseware products of plastics including stationery items ; Medical items of plastics; Miscellaneous Packaging items - flexible, rigid; Floorcoverings, leathercloth & laminates; and Plastic raw materials including

masterbates to Thailand. Thailand is among the top -25 export destinations for plastics from India. Our plastics exports to Thailand were valued at USD 126 million in 2022-23 and mainly comprised value-added plastics products like Plastic films and sheets; and Floorcoverings, leathercloth & laminates.
