We have pleasure in informing you that the Council is organizing India Pavilion for the first time at 34th edition of **Plastics & Rubber Indonesia** scheduled to be held from **15th - 18th November, 2023** at Jakarta International Expo, Kemayoran, Indonesia.

Trade between India-Indonesia of Plastic Products

Within plastics, India's exports to Indonesia were valued at USD 145 million in 2022. India's plastics exports to Indonesia primarily comprise of Plastic raw materials; Floorcoverings, leather cloth & laminates; and Consumer & houseware products. However, Indonesia's annual plastics imports are valued at USD 13.6 billion approx. and India's share in its imports is 1.2% which is quite low. India's plastics exports to Indonesia have the potential to grow by USD 6.8 billion. Product categories, within plastics, that have immense export potential for export to Indonesia include: Plastic films and sheets; Consumer & houseware products; Medical items of plastics; Packaging items - flexible, rigid; Floorcoverings, leather cloth & laminates; Plastic pipes & fittings; Cordage, fishnets & monofilaments and Plastic raw materials.

Reimbursement from MSME Ministry:

As per MSME Ministry IC Scheme, eligible MSME units can avail reimbursement of participation cost and expenses on following components with ceiling as below.

- Reimbursement of Booth Cost up to Rs. 3 lakh
- Reimbursement of Economy Class Airfare for 1 person from 1 MSME Unit.
- Reimbursement of Freight Expenses up to Rs. 50,000 for 1 MSME Unit.

The above reimbursement will be as per the guidelines under IC scheme after the exhibition.
