We have pleasure in informing you that the Council is organising the India pavilion at Arabplast 2023 scheduled to be held from December 13th to 15th 2023 at Dubai world Trade centre, Dubai, UAE.

ARABPLAST 2023 is one of the largest established trade fair in this region and has acquired a brand image over the years. It offers a unique opportunity for players in the plastic industry (all plastic items including master batches, additives and other auxiliaries, machinery and moulds and dies) to showcase your products not only to the target audience in UAE but also the entire Middle East and African Regions.

In the last 4 years India's plastics export to WANA Region have risen from USD 1,491 Million in 2018-19 to USD 1,907 million in 2021-22, representing a CAGR of 8.5%. Today India's plastic export destination countries in WANA region are United Arab Emirates, Israel, Saudi Arabia, Egypt and Bahrain. The Major items of India's export to WANA region were: Plastic raw materials (49%), Plastic films and sheets (12%) FIBC, Woven sacks, Woven Fabrics, Tarpaulin (7.2%).

Earlier edition of ARABPLAST2021 witnessed with 217 exhibitors from 30 countries and about 11230 visitors from 129 countries visited the show. It has once again re-established as NO.1 show in the region for plastics, petrochemicals & rubber industry.

PARTICIPATION CHARGES:

- Space only: Rs. 41,850/-Per sqm (Minimum bookable area is 27 sqm)
- Shell scheme: Rs. 47,970/- Per sqm (Minimum bookable area is 12 sqm)
- Corner stall or 2 side open stall will have an additional charge of 10%

Exhibitors should order separate power/ electricity connection for their stand.

PAYMENT SCHEDULE:

30% non-refundable payment along with (**Application form**.) Second instalment of 30% payment must be paid on or before 30th August 2023. Balance payment of 40% must be paid by 30th October 2023.

BENEFIT TO THEPARTICIPANTS:

Subsidized Space under MAI Scheme: Please note that we have sought the financial assistance under MAI Scheme for the year 2023 -24 from the Ministry of Commerce, Government of India. We will inform separately the quantum of Subsidy available to each exhibitor **(Subject to Government Approval)**. Any fluctuation in costing shall be adjusted with prior notice to exhibitions.
