Greetings from Plexconcil!

We have the pleasure in informing you that the PLEXCONCIL is organizing the India pavilion at RUPLASTICA (International Trade Fair for Plastics and Rubber) scheduled to be held from 23<sup>rd</sup> to 26<sup>th</sup> January 2024 at EXPOCENTRE, International Exhibitions and Conventions, Moscow, Russia.

### **Trade Potential:**

In 2022-23, India and Russia engaged in bilateral trade worth USD 49.4 billion. During the year, India's exports to Russia were valued at USD 3.2 billion while India's imports from Russia were valued at USD 46.2 billion. Within plastics, India's exports to Russia were valued at USD 92 million. India's plastics exports to Russia primarily comprise Plastic raw materials (40%); Plastic films and sheets (22%); Packaging items - flexible, rigid (10%); and Medical items of plastics (9%). However, Russia's annual plastics imports are valued at USD 13.8 billion approx. and India's share in its imports is less than 1.0%. India's plastics exports to Russia have the potential to grow by USD 7.1 billion. Product categories, within plastics, that have the immense export potential for export to Russia include: Consumer & houseware products of plastics; Plastic films and sheets; Medical items of plastics; Packaging items - flexible, and rigid; Floorcoverings, leathercloth & laminates; Plastic pipes & fittings; FIBC, Woven sacks, Woven fabrics, Tarpaulin; Cordage, fishnets & monofilaments; and Writing instruments & stationery.

### About RUPLASTICA (International Trade Fair for Plastics and Rubber)

For many years, the international trade fair for plastics and rubber – RUPLASTICA – has been representing a unique tool for business development in the polymer industry. It is the most relevant meeting point bringing together key industry players across the entire polymer market value chain from Russia, CIS,

Europe and Asia to showcase innovations, discuss current trends, and chart the course for the year ahead.
