Payment Schedule: 50% non-refundable payment along with application form and Balance payment of 50% must be paid by **30th September 2024**.

Application: Interested members are requested to confirm participation by sending the attached application form duly completed along with a 50% non-refundable advance payment. Please note application, once received (via hard/soft copy) would be considered a confirmed exhibitor and would abide by the terms & conditions of participation as mentioned by the Organizers of the Exhibition and Plexconcil. **The exhibition Application Form is attached.**

Benefit to the Participants: Please note that **we have sought financial assistance under the MAI Scheme for the year 2024 -25 from the Ministry of Commerce**, Government of India. We will inform separately the quantum of Subsidy available to each exhibitor once approved. Space subsidy and reimbursement of airfare (to the eligible Members), subject to government approvals & release of funds from the Ministry.

Visa Inputs: We suggest that you hold either a USA B1/B2 or apply for a USA Visa/Mexican Visa well in advance to participate in this show. The Council can only issue visa recommendation letters to the Member participating companies.
