- 8. Panel Chairman- Plastic Films & Sheets

In the election, only Ordinary members of the Council shall be entitled to vote and participate. The criteria for entitlement of the Ordinary member are as under:

- 1. Should be an Ordinary member of the Council.
- 2. The Ordinary member should have paid the subscription of the Council by 30th June, 2024 for the financial year 2024-25 as per the Articles of Association of the Council.
- 3. The Ordinary member should have filed export returns with the Council.
