Greetings!

Embassy of India(EOI), Brazil has informed that currently, 100 products are under consideration for tariff enhancement by the Department of Commercial Strategy of the Foreign Trade Chamber(CAMEX), Government of Brazil. After analyzing EoI, Brazil has identified 61 items of concern for India. Out of which the following 14 HS codes pertaining to our council; all of these are plastics raw materials.It may be further informed that the proposed duty of 20% from 12.6% is very high.
