This refers to the trailing mail given below we wish to inform you that the fifth session of the [Intergovernmental Negotiating Committee](#) to develop an international legally binding instrument on plastic pollution, including in the marine environment (INC-5), is scheduled to take place from 25 November to 1 December 2024 at the Busan , Republic of Korea.

Objectives of INC – 5 are :
