Export overview for Indian products to South Korean market:

- With regards to the plastic Industry, In the last five years India's plastics exports to South Korea have ranged between **USD 56 million to USD 68 million** per year to the world.
- The Major items of India's plastics export to South Korea were:
 - Plastic raw materials (52%)
 - Plastic films and sheets (19%)
 - Floorcoverings, leathercloth & laminates (11%).
- South Korea's annual plastic imports are valued at **USD 12.6 billion**.
- There is a potential for Indian plastic exports to South Korea to grow by **USD 8.0 billion**, especially in product categories such as plastic raw materials, consumer & houseware products, plastic films and sheets, medical items of plastics, packaging items of plastics - flexible, rigid and FIBC, Woven sacks, Woven fabrics, Tarpaulin.
