As you are aware, FEMA regulates foreign exchange transactions and promotes the orderly development and maintenance of the foreign exchange market in India. Therefore, it is necessary to understand the regulation thoroughly.

Pre-shipment Credit in Foreign Currency (PCFC) is financing provided by banks to exporters for covering costs before shipment. Understanding the correct application process is crucial for higher approval chances, cost efficiency, timely access to funds, compliance, and better terms.

And complete knowledge of proper documentation in export and import transactions is crucial, especially when dealing with banks. It will help you in compliance and legal requirements, smooth transaction processing, risk management, credit approval, customs clearance, proof of transaction, trust, and credibility.

*The session will be conducted by Mr. Nijay Gupta, a mentor at Finrex Treasury Advisors LLP, with 40 years of experience in banking and treasury. He has advised on establishing treasury, forex, and trade finance functions and held key positions at Antwerp Diamond Bank, Bank Muscat SAOG, and Abu Dhabi Commercial Bank. He also has experience in setting up the Money Transfer Company in Dubai and has imparted training at various institutions including Banks, FIEO, IMC, WIRC of ICMA, and ICAI.*
