We wish to inform you about the above mentioned trade notice issued by O/o. Addl. DGFT, New Delhi regarding the processing of pending claims under the incremental Exports Incentivisation Scheme (IEIS) for the financial year 2013-14

In connection with the instructions received from DGFT HQs concerning the cap imposed under notification No. 43 dated 25.09.2013, O/o. Addl. DGFT, New Delhi is processing pending claims under the incremental Exports Incentivisation Scheme (IEIS) for the financial year 2013-14.

All eligible exporters whose balance claims were withheld due to the cap imposed by Notification No. 43 dated 25.09.2013 are hereby invited to submit their supplementary IEIS claims.

**Key Guidelines for submission:**

1. **Eligibility:** Only those exporters whose claims were partially processed or withheld solely due to the imposed cap under Notification No 43 dated 25.09.2013 are eligible to apply.
2. **Submission Deadline:** The last date for submission of supplementary IEIS claims is 31<sup>st</sup> January 2025. Claims submitted after 31<sup>st</sup> January 2025 will not be admitted ordinarily. Claims not submitted by this date will be deemed withdrawn.
3. **Mode of Submission:** Applications must be submitted physically or via email to the office of the Additional DGFT, CLA, New Delhi ,along with all requisite supporting documents.
