Nepal is one of the growing economies in the South Asia Region. Nepal's GDP in 2023 stands at US\$ 41 billion, with per capita GDP of US\$ 1,319. The main economic sectors of the country are agriculture, textiles, carpet and garment industries, tourism, and service industry. Nepal's imports are valued at US\$ 14 billion, mainly comprising of petroleum products, iron and steel, machinery and equipment, electrical goods and vehicles while the exports stand at US\$ 1.3 billion and are dominated by the agricultural and textile industries.

India is the chief trading partner for Nepal for both imports and exports with India's exports to Nepal valued at USD 7.0 billion in comparison to India's imports from Nepal worth US\$ 0.8 billion. With regards to the Plastic Industry, India maintains a strong position with exports to Nepal worth US\$ 293 million and a trade surplus of US\$ 260 million to India.

**Nepal's annual plastic imports are valued at 680 million, almost 55% of which is catered to by India. There is a potential for Indian plastic exports to Nepal to grow by another US\$ 300 million, especially in product categories such as plastic raw materials, consumer & houseware products, plastic films and sheets, medical items of plastics, floorcoverings, leather cloth & laminates and packaging items of plastics - flexible, rigid.**
