Subject: Regarding inputs for Product Specific Rules of Origin under India-UK CETA

We wish to inform you that the Ministry of Commerce & Industry has sought comments/feedback/suggestions from exporters on the Product Specific Rules of Origin fixed under the recently signed India-UK CETA.

Rules of Origin are the domestic value addition conditions that must be satisfied by the exporters for availing duty benefits under this trade agreement.

These Rules specify the maximum permissible value of the imported inputs, minimum level of local value addition and conditions such as Change in Tariff Sub Heading (CTSH) or Change in Tariff Heading (CTH) to avail duty benefit under the agreement.

The following table provides Product Specific Rules of Origin applicable for various chapters under the purview of PLEXCONCIL, along with relevant data on India's exports to UK, exports to the world and untapped export potential.
