Masterbatches, Additives, Compounds, Fillers, Auxiliaries etc, Plastic Packaging, Plastic Construction Materials, Moulds, Recycling and Plastic Machinery, Finished and Semi-Finished products etc will have good potential in the Eurasian markets. Post pandemic the markets have opened and this event will give an excellent platform to tap this potential.

Trade overview

Within plastics, the trade is largely in favour of India with exports of USD 160 million to Turkey while imports from Turkey to India stand at USD 94 million, leading a substantial

trade surplus of USD 66 million for India.

India's plastics exports to Turkey primarily comprise of the following:

Plastic raw materials (69.5%),

Medical items of plastics (6.9%), and

Plastic films and sheets (4.9%).

The 2024 edition of the Plast Eurasia Istanbul show had 1600 participant companies from 48 countries and 75,239 professional visitors from more than 100 countries visited the show.
