In this regard, the RoDTEP Committee, constituted vide Order F. No. 602/5/2025 dated 01.10.2025, has requested submission of relevant data from eligible exporters for reviewing and updating the existing RoDTEP rates.

2. **Period of Export : 01.04.2024 to 31.03.2025**
3. **The submission should be supported by representative documents, such as:**
  - **Tax invoices of inputs used**
  - **Shipping bills of exported products**
  - **State Government notifications on taxes/levies (electricity duty, mandi tax, etc.)**

4. The format consists of:
  - Part 1: General information of the manufacturing unit
  - Part 2: Item-wise information covered under the RoDTEP Scheme
