Subject : Regarding Inputs Requested on Proposed Import Duty Changes on Petrochemicals & Feedstocks

We are in receipt of a communication from the Department of Commerce regarding the proposed increase in import duty on key petrochemicals and the elimination of import duty on petrochemical feedstocks.

Point no. I. Import duty on key petrochemicals be increased to at least 10% (as given below) for the relevant industry to survive and grow and to continue its role as a key enabler in the national economy.
