Subject: DGFT Trade Notices under Export Promotion Mission (EPM) – Niryat Disha & Niryat Protsahan

The Directorate General of Foreign Trade (DGFT) has issued a series of Trade Notices during December 2025 – February 2026 announcing multiple interventions under the Export Promotion Mission (EPM), covering market access, export credit, logistics, compliance, trade intelligence, and capacity building, with a strong focus on MSME exporters.
