**Subject: Standard Operating Procedure for claim submission as per DGFT's Notification No. 65/2025-26 dated 19.03.2026 under RELIEF Components I, II and III.**

With reference to **DGFT's Notification No. 65/2025-26 dated 19.03.2026** ([https://membership.plasticsepc.org/mails\\_images/20260320114607.pdf](https://membership.plasticsepc.org/mails_images/20260320114607.pdf)) regarding **RELIEF** an intervention to support exporters impacted by extraordinary freight escalation, heightened insurance premia, and war-related risks in the Gulf and West Asia maritime corridor.

A time-limited RELIEF intervention under the **Export Promotion Mission, to be implemented through the Export Credit Guarantee Corporation of India (ECGC)**, is operationalised to address elevated export risks arising from geopolitical disruptions in the Gulf and West Asia maritime corridor.

The RELIEF interventions are meant to cover losses arising due to war-related risks and associated political risks in the affected countries. It shall cover Shipments with Full Container Load (FCL), Less than Container Load (LCL) or Reefer containers (perishable cargo) destined for countries such as United Arab Emirates, Saudi Arabia, Israel, Kuwait, Qatar, Oman, Bahrain, Iraq, Iran and Yemen for delivery or for trans-shipment.
